8. Proposed Estimates 2020/21

(a) Christmas Lights - Field and Lawn have advised that the cost for installation/removal, storage and servicing of the Christmas Lighting scheme in 2020 will remain at £14,300.00. Members to consider whether to approve and accept the quotation or go out to tender next year.

(b) Billericay in Bloom - due to the working party meeting held on 1st October being inquorate members are asked to recommend a budget line of £1,900 for 2020/21.

9. Festival Gardens

Skippers have provided a quotation for removal of the hedge behind the railings in Crown Road at a cost of £1,500. It is hoped this action will deter young people from congregating there and creating a nuisance. Members to decide whether to approve this work.

10. Mayflower 2020 Sculpture

Julian Whybra from the Mayflower Twinning Association is preparing a programme of Mayflower 2020 events and members are asked to **(i)** consider his request to list the statue unveiling as taking place in Summer 2020, or **(ii)** to NOT publicise the unveiling as it will be a private, invitation only event.

11. Water Filling Station in the High Street

Cllr Roessler has proposed that a water filling station is provided for residents in the High Street. Members are therefore asked to consider whether further investigation should take place into **(i)** identifying a suitable High Street location, and; **(ii)** to identify the project cost. This would include both the initial cost of purchase and installation plus future maintenance and water costs. As an indication the installation of a water filling station in Lake Meadows is costing approx £5,500 and there is already a water supply there.

12. Discussion Item - Re-instatement of Night Street Lighting

A resident of Regent Drive recently expressed concern to the Borough Council about the street lights being switched back on at night. He was told by BBC that representation should be sought from the Town Council if any residents wish their lights to remain off. Members to discuss a way forward should residents approach the Town Council.
