Recent large applications include land south of London Road for a Lidl store and 130 dwellings, and there was a large public turnout speaking again it. Also, 89 High Street, the original application had been accepted but they had used a second application to add a large extension and again many residents attended to express their concerns and objections. The ongoing application for 97 Chapel Street was finally passed by Basildon Borough Council as was the re-building of Reids in Laindon Road.

## (b) Health, Well-being and Environment Committee

Cllr Moore presented the minutes of the Health Well-Being and Environment Committee meeting held on 20<sup>th</sup> February 2024.
